- How do your internal auditors maintain and document their independence?

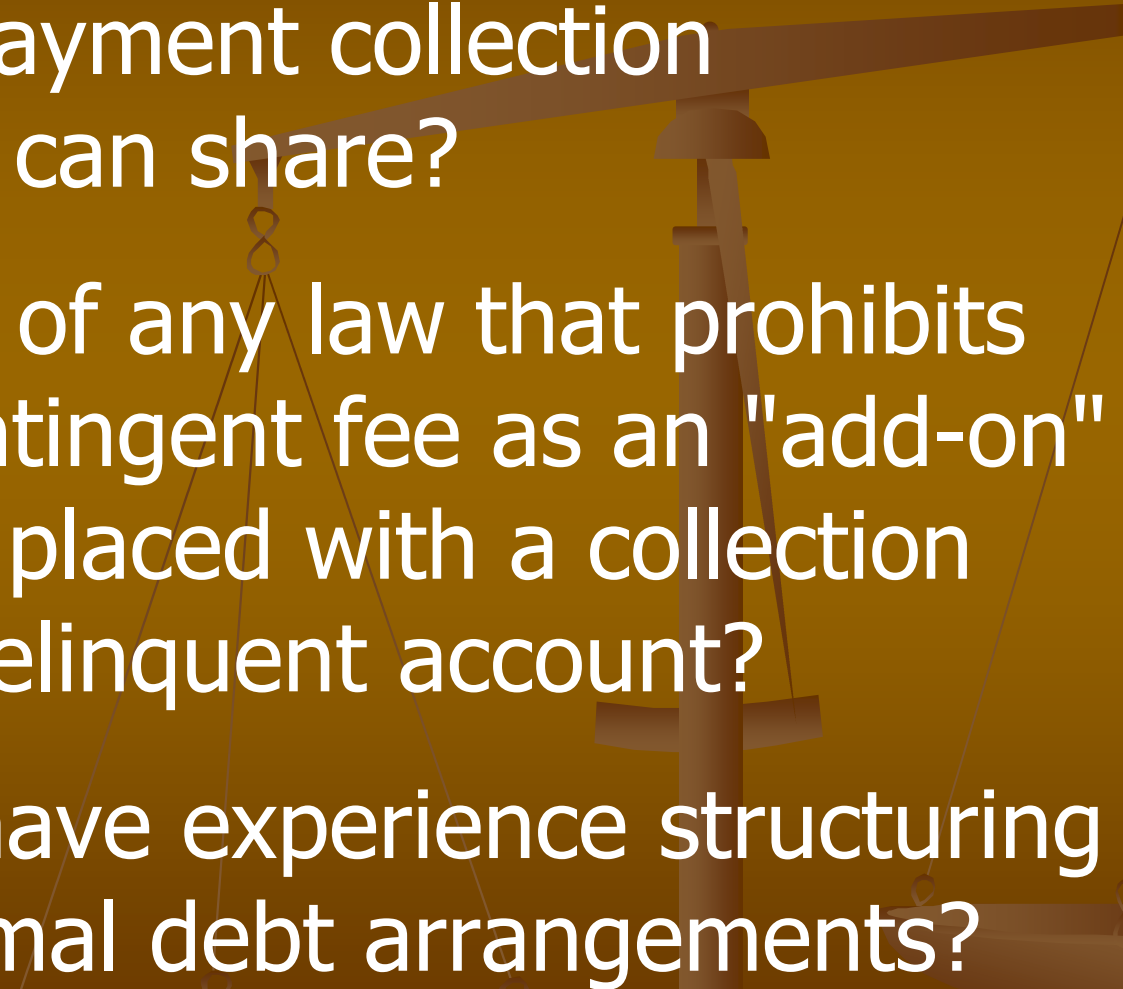
# Example List Serve Postings

## Budgeting

Florida Statute 553.80 (7) requires building fees, fines and investment earnings related to the fees, be used solely for carrying out the local government's responsibilities in enforcing the Florida Building Code. It also requires any unexpended balances to be carried forward to future years. Also, "the total estimated annual revenue derived from fees, and the fines and investment earnings related to the fees, may not exceed the total estimated annual costs of allowable activities."

How are other cities handling their Building Department? Ours is one division of the General Fund. Is any one using a Special Revenue or Enterprise Fund to account for their Building Department revenues and expenditures?
